Division 42 Award Recipients

Rosalie G. Weiss Award

Jana Martin has been an exceptional and dedicated leader in psychology, both in psychological practice as well as expanding her career beyond the traditional parameters of the profession into executive management. In the sphere of community service delivery, she has held leadership positions of Director, Chief Psychologist, Clinical Program Director and Psychological Consultant. Jana is currently CEO for the American Insurance Trust and President, Trust Risk Management Service, a premiere organization that provides risk management tools, financial security, and liability insurance for psychologists. She has served in governance positions on local and state levels within various organizations consisting of being President of the California Psychological Association (CPA) and Los Angeles County Psychological Association, President of Division 42, President and Board member of St. Mary's Hospital and Children's Dental Foundation and Board of Directors Trustee for the American Psychological Insurance Trust. For 10 years, Jana was the California Public Education Coordinator for the APA. She has published widely and has in excess of 300 appearances including media presentations and continuing education workshops. In recognition of Jana's distinguished service and leadership, she has received multiple accolades and awards, including twice being heralded as a Woman of Distinction, recognition by Senators as a nominee for Woman of the Year, Distinguished Contribution to the Profession of Psychology Award from CPA, Presidential Citation from APA, and Distinguished Contribution to the Los Angeles County Psychological Association Award.

Lifetime Achievement Award

Over the course of his career, **Stanley Graham** has been a trailblazer, model psychologist, and renowned scientist, educator and clinician who has provided lasting positive effects for the profession and the public. Most notably, Stanley was instrumental in founding the Division of Psychologists in Independent Practice (42), and served as the Division's first President, and of Division 29 (Society for the Advancement of Psychotherapy). He served as President of the APA and President of the NY State Psychological Association. He played a critical role in the development and evolution of the Committee for the Advancement of Professional Practice, the Practice Directorate. Stanley served twelve terms as Representative on APA's Council (COR). In recognition of his contributions, he was the recipient of the APF's Gold Medal for Lifetime Achievement in The Practice of Psychology. Academically, Stanley has served as an Associate and Senior Research Scientist, and as Chair of the Psychology Department of the NY State Institute of Psychobiologic Studies. He has authored 37 professional publications and has made over 100 presentations at APA and State Associations. Stanley now serves as Distinguished Research Professor at the California School of Professional Psychology at Alliant University.

Distinguished Psychologist of the Year Award

Lisa Grossman and Jeffrey Younggren are co-recipients of the Psychologist of the Year Award.

"Service and Leadership" are Lisa Grossman's middle names. She is an eminent psychologist with sustained, impactful service and outstanding achievements to psychology on state and national levels. Lisa is a highly respected, astonishingly productive and innovative leader, and an inspirational role model to many. She has been President of the Illinois Psychological Association, along with being consistently involved in APA governance, hav-

ing served on the APA Board of Directors (BOD), President of Divisions 42 and 31, and on multiple other boards and committees within the APA (Board of Professional Affairs, Policy and Planning, Finance Committee, the APA COR, and President of the American Board of Clinical Psychology). She has assumed almost every leadership position within Division 42. In recognition of Lisa's exceptional devotion to psychology, advancement of practice, and major contributions, she has received the APF 2014 Rosalee G. Weiss Award, APA 2010 Award for Distinguished Professional Contributions to Independent Practice, Karl F. Heiser Presidential Award for Advocacy, Division 42 Mentoring Award, and Outstanding Psychologist in a SPTA by Division 31. Moreover, in 2014, Lisa, along with Steve Walfish co-edited a major book publication *Translating Psychological Research into Practice*.

For over 40 years, Jeffrey Younggren has demonstrated exemplary service in clinical and forensics psychology, the education of other psychologists, as well as his ongoing contributions to Division 42 and to APA. From 1998 to 2015, Jeff was a risk management consultant to the APA Insurance Trust, whereby many psychologists were able to benefit from his excellent workshop presentations packed with important information in ethical, legal and risk management issues. His local, state, and national recognitions are impressive. Jeff received the Silver Psi Award from CPA in 2009, APA Presidential Citation in 2011, the Distinguished Contribution to Psychology as a Profession Award through the CPA in 2014, and the Presidential Citation from the Tennessee Psychological Association the same year. Jeff has served and chaired the CPA Ethics Committee and the APA Ethics Committee. He is past President of Division 42, a current COR, and was a former APA Accreditation Site visitor. Jeff is the Associate Editor of the *Journal Ethics and Behavior* and was the Consulting Editor for *Professional Psychology: Research and Practice* for five years. He has 19 refereed publications and 33 non-refereed publications as well as authoring seven books and chapters.

Distinguished Public Service Award

Josephine Johnson is most deserving of this award through her contributions and commitment to the provision of psychological services to communities, along with her active involvement in the areas of multiculturalism, diversity, advocacy, and self-care. In addition to her private practice, Jo has served as a consultant to residential treatment centers, community mental health agencies, a special education center, and a university counseling center. Furthermore, Jo has contributed to the field and to the public with her APAPO presentations and publications on topics of Integrating Multicultural Competencies into Independent Practice and Ethics and Multiculturalism: Advancing Cultural and Clinical Responsiveness. She was on the Task Force to Review and Update the Multicultural Guidelines and chaired the Task Force on Implementation of the Multicultural Guidelines. Jo has been an active leader in state, division and APA governance, having served as President of the Michigan Psychological Association (MPA), MPA FAC, APA BOD, Division 42 COR and chair of the APA Membership Board. She has been honored with awards by the APA Committee of State Leaders Diversity Delegates, MPA, Farmington-Farmington Hills Multicultural Multiracial Council, and Pepperdine University.

Mentoring Award

Carol Falender is a nationally and internationally recognized consultant, lecturer, trainer, workshop presenter, and mentor on clinical supervision, competency-based approach to supervision, and ethics of supervision. She has been the Director of Training and Research at Saint John's Medical Center. Carol is presently chair of the APA Board of Educational Affairs Supervision Task Force, Consulting Editor for Training and Education in Professional Psychology, and chair of the CE Committee of CPA. Carol is highly published in over 50 journals, including the areas of education, supervision and training. In 2015, she was the presenter for an APA Psychotherapy Supervision Video Series. Among her recognitions, Carol has been honored with a 2014 APA Presidential Citation for innovative contributions to the theory and practice of clinical supervision, 2013 recipient of the LA Psychological Association Distinguished Service to the Profession of Psychology, and Silver Psi Award from the CPA for Outstanding Service.
